Bucks County Grant

Recently, the Newtown Historic Association was awarded a grant from the Bucks County Community Development Advisory Board in the amount of \$12,925 specifically for roof repairs on the Court Inn. This grant is the first step in raising the funds needed to enable work to begin replacing the 20+ year old roof of the Court Inn. Additional funding sources for the completion of this project will be solicited in the coming months.

Garden Initiatives

The Court Inn was decorated by members of the Countryside Gardeners for the recent Christmas Open House Tour. The Countryside Gardeners are a local garden club and have had the opportunity to hold two meetings this past year at the Court Inn. President, Lee Gittens, is in the process of a grant proposal to the National Garden Clubs, Inc. for the "Restoration of existing gardens at Historic Sites." The grant is provided by the Principal Financial Group Grant Project, which enables Garden clubs to apply for funding up to \$3,000 in matching funds. If the grant is awarded, the matching funds will be raised by having garden tours, lectures and receptions co-sponsored by the NHA and Countryside Gardeners. The grant and matching funds will be used to begin work in early spring to restore the existing gardens at the Court Inn.

Hicks Family Items

In November 2002, the Newtown Historic Association received a significant donation of articles relating to the family of Edward Hicks from Mrs. Katherine K. Fabian, currently residing in Philadelphia, but who previously resided at the Hicks' Home "Stenton" at 35 South Congress Street in Newtown borough for over 30 years. Some of the more interesting items were:

- 41 daily journals/diaries of Sarah Worstall Hicks covering the period 1871 to 1941 found in the Carriage House.
- 61 black and white negatives of the Hicks family descendants taken from 1885 to 1948.
- 45 newspaper articles pertaining to the Hicks/Lee family from 1891 to 1970.
- 12 daguerreotypes of prominent Newtown citizens from mid-1800's until early 1900's.
- 12 World War II ration book sets of Hicks family members.
- Garland autograph album circa 1902 showing Hicks family autographs.
- 12 letters handwritten with senders and receivers within the Hicks family.
- One two-seat sleigh manufactured by Randall Carriage Company of Newtown that was owned by Isaac Hicks.
- One Silver Cup inscribed Marian Clara Hicks.
