



MERCER MUSEUM

"Mercer by Moonlight" -- Newtown Night Tuesday, October 6, 5:00 to 9:00 P.M.



The Bucks County Historical Society is hosting a series of free evenings at Mercer Museum to a number of municipalities in Bucks County which are celebrating or have celebrated their Tricentennials. OCTOBER 6 is NEWTOWN night, and all residents of the Borough and Township are invited to attend free of charge. The Museum will have on display articles from Newtown; and our Association, in cooperation with the Newtown Joint Historic Commission, will provide an exhibit table. The Museum is located at 84 S. Pine St., in Doylestown (telephone 345-0210). The support of our membership is solicited. Come out and back this effort.

TOLL HOUSE



The DURHAM PIKE TOLL HOUSE was in operation from approximately 1870 to 1920. At the intersection of Sycamore St. & Durham Pike, it provided modest living quarters for the tollkeeper and his family and a gate which could be raised and lowered as tolls were paid. It was twice saved: first, by the Goodnoe family when it was moved to its present location on Durham Rd. at Eagle Rd. to make way for the Dairy Bar, in 1955; and more recently, when the developer of Village at Newtown, Terracon, with the encouragement and assistance of the Historic Commission, the cooperation of the Township and the support of this Association, allowed it to stand as a historic landmark and financed its restoration.

At this point in its history, PENN'S NEW TOWNE QUESTERS have taken up the ball by undertaking the furnishing of the Toll House kitchen. Already on hand was a cooking stove of the period, to which they have added to date: a pine jelly cupboard, a hoop skirt rocking chair, a kerosene hanging lamp and various kitchen utensils, including an apple basket, a wire egg basket, a blue agate coffeepot, and miscellaneous tools, bottles and crocks. These acquisitions have been funded by the \$1,500 which these Questers have earned from a plant sale, a bus trip to New Castle, Delaware, and by a grant from the Pa. State Questers. The project will be capped off when the Toll House becomes part of this year's Open House in December. This has proven to be an exciting and rewarding undertaking.
