The Newtown Friends Boarding Home

In 1895 at the Philadelphia Yearly Meeting of Friends the following minute was adopted: "In connection with the answer to the Sixth Query, there was presented by a valued Friend, Mary M. Thomas, a concern relative to a Home for aged and infirm Friends of limited means. That these should be provided for where the little they may have will secure in their declining years greater care and more comfort than such can individually procure for themselves".

A committee was named to consider the matter and to report at the next Philadelphia Yearly Meeting. Eight Friends from the Bucks Quarterly Meeting were on this committee. These Friends were Isaac Eyre, Mark P. Rich, Watson Kenderdine, Oliver H. Holcomb, M. Ellen Longshore, Harriet L. Worthington, Sarah Ann Wildman and Cynthia S. Holcomb.

In 1896 the committee reported, in their judgment, such Homes were needed and they recommended the establishment of the same, advising "they should be located near a meeting." Following this report, was this communication from Joseph T. Jeans "To the Philadelphia Yearly Meeting of the Society of Friends held at Race and 15th Streets, the sum of \$200,000 is donated from the estate of Joseph Jeanes to assist in the establishment and maintenance of Boarding Homes for the Aged and Infirm amongst Friends and those in sympathy with us".

At the Bucks Quarterly Meeting following the Philadelphia Yearly Meeting in 1896, a committee was named to ascertain if a Home was needed for the Friends belonging to the Bucks Quarterly Meeting. Four members were named from each Monthly Meeting to make a canvass. The committee was as follows: David Palmer, Charles Satterthwaite, Mercianna Merrick, Hannah Altemus, Amos Satterthwaite, George C. Atkinson, Samuel Hart, Anna C. Atkinson, Elizabeth Cadwallader, Hannah Kenderdine, Agnes S. Ely, William M. Ely, Stephen Betts, John M. Stapler, Algernon Cadwallader, Rebecca F. Johnson, Elizabeth Laing, Walter Laing, Samuel Swain, Agnes S. Palmer, Elizabeth D. Taylor, Jane D. Vail, Horace T. Smith, Ezra Michener, Ema D. Eyre, Letitia W. Twining, Abram R. Vail and Josiah Wilson.

The Fourth Bucks Quarterly Meeting in 1896 at Wrightstown, the following Monthly Meetings contributed toward the maintenance of a Home: Falls Monthly Meeting, Bristol Monthly Meeting, Middletown Monthly Meeting, Wrightstown Monthly Meeting, Buckingham Monthly Meeting, Solebury Monthly Meeting, Makefield Monthly Meeting and Quakertown Monthly Meeting. The committee rented a large brick house of Dr. Lettie A. Smith, now known as Chancellor Apartments and opened the Home there on Fifth Month 3, 1897.

They received \$788.67 from the Joseph Jeanes estate. David and Agnes S. Palmer and daughter Elizabeth were selected to have charge of the Home.

In 1898, through the representative of the Buckingham Monthly Meeting, Anna C. Atkinson and Edward M. Paxson became interested and made an offer to build a Home costing \$10,000, if the committee could raise a like sum for an endowment fund. The Bucks Quarterly Meeting raised that amount, and Judge Paxson contributed \$30,000. This gift was given in honor of his father and mother, Thomas and Ann Johnson Paxson.

A lot was purchased from Emmor K. Janney, who was willing to sell provided that the entrance might face his ancestral home on Congress Street, " and the stable and other out buildings be placed to the rear or westernly side of the lot". The front preferred was on Centre Avenue. To satisfy all interested, a compromise provided for two entrances. Later, small pieces of ground were purchased from Myra Hibbs, Maria Twining and J. Pemberton Hutchinson; and from the heir of George Brooks, the committee purchased an orchard. Judge Paxson paid for all these additions.

On Seventh Month 6, 1899, the date stone was placed on the south wall, and the "Home Committee" walled in behind the date stone, a jar containing data relating to the Home. On Third Month 3, 1900, the Home was formally dedicated. Judge Paxson passed the papers and keys over to George C. Atkinson, president of the committee, who in well chosen words, accepted on behalf of the Bucks Quarterly Meeting. Words of appreciation were also expressed by Samuel Swain, Amos Satterthwaite and Walter Laing.

The Home is a three story, native brownstone building, with numerous dormer windows and it has accommodations for 50 guests. A bronze tablet in the reception hall bears the following inscription: "This building was erected in 1899 in memory of Thomas and Ann Johnson Paxson by their son, Edward M. Paxson". Judge Paxson was instrumental in having a number of books given to the Home's library by John Wanamaker, John Hayes, J. Lober Welsh and M. Stanley Quay. Theodore Roosevelt sent an autographed copy of his "Winning of the West". In 1912, with funds bequeathed by Anna T. Jeanes, an addition was built to the Home for an infirmary. The Home is under the care of the Bucks Quarterly Meeting, which appoints three trustees, known as the "Committee of the Friends Home", to administer its affairs and care for an endowment fund which has been enlarged from time to time by legacies and contributions.

Editor's Note: From 1938 to 1945 Edward R. Barnsley, well-known Newtown collector, historian and preservationist, published a weekly article on Newtown history in the local newspaper called the Newtown Enterprise. These articles are in the collection of manuscripts housed in the Barnsley Room of the Newtown Historic Association, and this article has been reprinted from this collection.
