Volunteering to Serve and Preserve Newtown's Legacy

Quietly, he goes about his business helping out in any way necessary at the Court Inn. His duties typically range from tending the fires throughout the day during the annual Open House Tour; to opening the Court Inn research center early on Tuesday mornings and Thursday evenings preparing for visits from interested patrons; to spending many hours tirelessly assisting researchers and staff identify old photographs of Newtown or researching details associated with Newtown-related historical topics.

The Newtown Historic Association is fortunate to benefit from the service of Maurice J. (Mike) Donovan, a lifelong Newtown resident and long-time volunteer at the Court Inn. Mike often calls upon his memories of Newtown from the days when he had a part-time mail route as a young man, or from his experiences as a member of the Class of 1945 at Newtown High School, as well as from serving his country in the U.S. Coast Guard as a member of the combat rescue flotilla in World War II. Perhaps one of the least-known, yet most passionate, interests Mike shares is his endless work to honor and remember those fellow classmates and Newtown residents who sacrificed their lives during World War II.

In recognition of his work, the Chancellor Street Center Committee and the Morell Smith Post #440 of Newtown held a special dedication of the permanent new World War II Honor Roll at the Chancellor Center on May 21, 2005. Over 200 people attended the dedication of the Honor Roll that memorializes the eleven Newtown High School students who were killed in action or lost at sea during World War II.

The Honor Roll is a testament to the brave men who willingly gave their lives so that we might enjoy the many freedoms our country has to offer.

For years, Mike has worked to recognize Newtown's World War II veterans. Over the years, he's gathered extensive information about their service by researching American Battle Monuments Commission documents and local archives. In addition, he contacted each family to collect photographs and details about the lives and deaths of these veterans. Mike has documented the contributions of these men so they will never be forgotten. As historian of the American Legion Morell Smith Post #440 and as an active member of the Newtown Historic Association, Mike Donovan has worked to organize the recognition of Newtown's men and women who have served in the Armed Forces of our country. At the dedication service, family members were presented with a framed biography of their loved ones, spelling out details, such as rank, where they served, where and when the died, and the medals they received.

The display in the Chancellor Center contains a biography and picture of each veteran, including replicas of all medals received. The medals were donated by an anonymous donor.

At the dedication, Mike was presented with a citation from the Pennsylvania House of representatives honoring him for his time and energy given toward the creation of the WWII memorial at the Chancellor Center.

Newtown is fortunate to have long time members of our community and volunteers, like Mike, who work hard to preserve the memory of both Newtown and its veterans.

Helen Randle, Founding Member & First President (1911-2005)

Helen Randle, long-time resident and volunteer in Newtown, died on July 30, 2005 at the age of 94. Born in Philadelphia in 1911 to Thomas J., a renowned artist and lithographer, and Ray M. Flanagan, Helen graduated from Germantown High School in 1928 and Swarthmore College in 1933 with honors in mathematics. In 1946, she moved to Newtown with her young family and lived on Frost Lane for almost 50 years. She moved to Pickering Manor in 1995 where she resided until her death.

While raising her two daughters, Helen worked for the Council Rock School District and the Natural Resources Department of the County Planning Commission, and later for the Township. But it is for her volunteer work and her dedication to the betterment of the greater Newtown community that Helen will be best remembered. She "has become something of an institution in Newtown," wrote Sue Blank in an article written about Helen in The Advance of Bucks County in May 1986. It was in September of that year that Newtown honored her for forty years of service to the community at a dinner at the Northampton Valley Country Club. Little did anyone know that this dedication and service would continue for another twenty years.

During the time that Helen's daughters were in school, she was very active in the Newtown school system. She organized and was first president of the PTA and was later secretary of both the Newtown Joint PTA and the Council Rock PTA. She was a member of the Board of the Council Rock School District and president of the Newtown Joint School Board.

Although she still remained active in the school system for many years, she later turned her energies to local government, and historic and natural preservation. She was a founding member and first president of the Newtown Civic and Historic Association (now the Newtown Historic Association, Inc.) and chairman of the Newtown Joint Historic Commission. In March 1998, Helen and her colleague, Elizabeth "Dolly" Gish, were honored by the Newtown Historic Association for their 30 years of work and dedication to the preservation of historic properties in and around Newtown. Thanks to their efforts, numerous historic properties, including White Hall on State Street, the Brookside House, which was part of the Twining Farm, houses at Newtown Grant and Newtown Crossing, the Toll House at the Village at Newtown, the Lovett House, the Tyler Park Farmhouses, and the McMaster House, were preserved.

In addition to her interest in historic preservation, Helen was an active member and president of the League of Women Voters, a member of the founding board of the Neshaminy Valley Youth Center, a writer for the Advance of Bucks County, a longtime volunteer at the Newtown Library, secretary of the first Bucks County Government Study Commission, member and secretary of the Newtown Township Planning Commission, and one of a team of three who took on the task of codifying the ordinances of Newtown Township, Newtown Borough, Wrightstown, and Upper Makefield and secretary-treasurer of the Joint

Zoning Council until 1992. "I recall that she was always busy, volunteering on one committee or another, but as a single mom, she always had time for her girls. She was there for us 120 percent," said one of her daughters. "She was an incredible woman and role model."

In the late 1970s, Helen and fellow members of the Newtown Township Lanning Commission saw an opportunity to acquire for a recreational park more than 30 acres of land on Swamp Road, land previously owned by Mr. and Mrs. George F. Tyler that they had given to the state. It took close to 10 years of perseverance, but in 1987 the acquisition was complete and the land was developed as Swamp Road Park. In June 2002, the park was renamed Helen Randle Park in her honor. "There could be no better tribute to Helen than to have a park named after her," said her good friend, Lorraine Pentz. "For generations to come, people in the community will be able to enjoy this park and see the name of the person who made it possible on the sign at the entrance. That's quite an honor for an honorable lady."

Helen is survived by her two daughters, Judith Iden of Upper Black Eddy, PA, and Patricia Hawthorne of Baltimore, MD, four grandchildren, two great-grandchildren, and a sister, Jane Hack, of Ocean City, NJ.

"The Historic Buildings of the Tyler Estate and Tyler State Park" will be presented by Jeff Marshall of the Heritage Conservancy. Tyler State Park consists of over 1,500 acres in Bucks County. Before becoming a state park, the land was owned by Mr. & Mrs. George F. Tyler. By combining the smaller farms and by astute management, the property became a self-sustaining and even a profitmaking investment during the Depression era. The old original stone dwellings in the park stand as fine examples of early farms of rural Pennsylvania. Some structures date back to the early 1700s. Original farm houses are currently being leased as private residences. The presentation will illustrate how the properties and dwellings were acquired and how they look today. The public is invited, refreshments to be served.
