Did You Know?

(Excerpt from the Daily Democrat, Doylestown, October 21, 1912)

Department of Local History: The Lenni Lenape Indians

The Stroudsburg Record is publishing a very interesting series of historical articles on "The Pocono Region." The article last week on the Indians in this section is reproduced here, in the belief that it will be read with much interest by those who have been following the Democrat's Department of Local History.

The Indian tribes who dwelt in the Pennsylvania forests at the time of William Penn's arrival in the Province call themselves the "Lenni Lenape" or "Original People," notwithstanding an obscure tradition among them, that their ancestors ages back had emigrated here from the Mississippi and expelled a more civilized nation probably the "Mound Builders" the evidences of whose settlement are scattered over the great Western Valley of the United States and in Pennsylvania.

The Lenape Indians (generally known as the Delawares) spoke the language and were separated into three main divisions of which tribes of the "Unami" (People down the river) with totem of the turtle; and the "Unalachtigo" (People near the sea) with the totem of the turkey, dwelt between the Atlantic and the Kittatinny or Blue Mountains extending as far south as the Potomac, while the "Minsi" (People of the stony lands or mountains) with the totem of the wolf, the most active and war-like of the whole nation, occupied the mountainous region between the Kittatinny Mountains and the sources of the Susquehanna and Delaware Rivers, "kindling their council fires" at the Minisink flats above the Delaware Water Gap.

Annual Report and April General Meeting

The Newtown Historic Association annual report and April general meeting will be held at Bucks **County Community College (BCCC)** on Monday, April 17th, starting at 6:00 p.m.

The annual report portion of the evening will occur from 6:00 p.m. to 6:30 p.m. in Rollins Hall Room 139 (Gallagher Room) and admission is free.

The general meeting will be a joint meeting between the NHA and BCCC, and will take place immediately after the annual report from **6:30 p.m. to 9:00 p.m.** in the main auditorium of the **Zlock Performing Arts Center.** The guest speaker is Daniel Tyler, grandson of George and Stella Tyler. The presentation title is, "George F. Tyler: A Synergy of Being and Doing."

Mr. Tyler is a retired professor of history at Colorado State University and author of "Bucks County's Benevolent Squire: In Search of George Frederick Tyler." He will show how his grandfather and grandmother, Stella Elkins, managed to represent the class of "Perennial Philadelphians" into which they were born, while at the same time used their talents and inherited wealth to benefit society. In addition, Matthew Metcalf, Coordinator of Historic Preservation at BCCC, will provide an informative overview of the

architectural history of the Tyler mansion.

After the lecture, attendees will be provided with a private, behindthe-scenes tour of the Tyler mansion. The special tour will include rooms that are generally off limits to the public.

NHA Receives a Grant

The Half-moon Inn was built in 1733 and it is now 290 years old. The original stone foundation under parts of the Inn are in serious need of restoration. While the foundation in one room of the basement has been restored, the rest is all original and needs to be fixed. There are sections where the stones have completely fallen out of the walls and others where large sections of the mortar between the stones is completely missing. Given that the foundation supports the Inn structure, this is something that needs to be addressed.

The NHA is undertaking to repair the most serious issues with the foundation in two of the five basement rooms with the Halfmoon Inn Stone Foundation Restoration Project. With this in mind, the NHA applied for and received a Bucks County Tourism grant from Visit Bucks County to begin the needed repairs. The \$2,500 grant, along with funds from the NHA, enabled the restoration to the mortar joints of the foundation under the front entry room at the Inn. Country Stonework completed this work using historic lime mortar.

There is one other basement room, under the Tavern Room, that needs to have the mortar joints restored and finished using original colonial ridge pointing. The needed funds for this room are \$10,300 and are yet to be secured.

(The NHA greatly appreciates Bronwyn Jones for volunteering many hours of her time to prepare and submit this grant application, secure the contractor, and see this project through to completion.)



You Beautiful Jerkinhead


See that strange, stubby looking dormer? That's a jerkinhead roof on a wonderful old Newtown house.

The Heston House



The Heston House stood on South State Street near where the liquor store is today. John's Barber Shop was a carriage house on the same property and is shown on the 1886 atlas.

The rear portion was built in 1723, as evidenced by a date stone found when the house was demolished. The two-story front portion of the house was built in 1798 by Aaron Phillips, blacksmith, who tore down the old log house and blacksmith shop. The log house was rumored to be the home of

one of Newtown's first settlers, James Yates. Another possible location for Yates' home is this.

John Atkinson, whose involvement with the Doans of Plumstead is well known, lived in the house during the Revolution and carried out blacksmithing from his stand on the property.

Atkinson's Doan Connection

The outlaws were harbored by John Tomlinson, who then owned the large farm in Wrightstown now belonging to Mrs. Charles Williams, and it is here that the plans for the robbery were laid. John Atkinson, who carried on blacksmithing in a shop on the property now of Dr. Heston, was frequently called upon by the Doans and their companions to repair their guns, and it was he who kept them posted as to the movements of Treasurer Hart, the probable amount received by him from the various collectors, and when the treasury building was without a gnard; and as compensation for his services he received a small portion of the stolen funds. 

Semiquincentennial Exhibition Update

Plans continue to move forward with the Semiquincentennial Exhibition that will be installed on the second floor of the Half-moon Inn. Over the past few months, we have received donations that will cover the majority of the costs for developing the exhibit and displays.

The NHA's Semiquincentennial Exhibition will be displayed in a timeline fashion across two rooms on the second floor of the Inn. Interesting and unique artifacts, photographs, and memorabilia will be used to tell the story of Newtown's notable past. The Semiquincentennial displays will be comprised of a blend of wall-mounted photos and text combined with relevant artifacts displayed in custom display cases.

Each of the six walls in the two rooms will have a different wall mural background over a timeline of significant dates in Newtown's history. The timeline will consist of 28 significant date panels on the following subjects.

After the wall graphic timeline is installed by the contractor, the committee will focus on the curation of the physical items to be displayed and the creation of the exhibit display cases and stands. It should be noted that the same contractor has agreed to a similar, materials-only, offer to create the display boxes and stands.

We expect to have the full-length wall murals installed this month, so individuals visiting the Half-moon Inn can begin to enjoy them.


Once the wall murals are installed, the NHA will send a notice to our membership.

The real work will be reviewing the accessions and determining which artifacts to display. The committee will spend the next year or more on that part of the project.



1962: Washington's Headquarters

During the Revolutionary War, General George Washington commanded America's Continental Army for several days from the brownstone house located at the intersection of Swamp Road and Sycamore Street. The original house was torn down in 1863, and completely rebuilt on the old foundation, of similar lines, out of the stone from the original Headquarters House. When the brownstone house was hastily demolished by developers in 1962 (the second and final time the house was razed), it inspired a chain of events that resulted in the formation of the Newtown Historic Association in 1964 to stimulate interest in, and preserve, the history of Newtown.

Energy Cost Savings

Last year, the NHA installed new storm windows, and converted the heating system from oil to natural gas, in the Half-moon (Court) Inn.



This year, we contracted for more favorable natural gas rates with a new energy supplier. These new rates will take effect this month.

We have already seen very positive reductions in our energy costs with these improvements and, once the new gas rates become effective, we are expecting to see a potential 30% reduction in our overall energy costs for the Court Inn.

We will be taking the same approach with our electricity costs to continue to build on these positive changes to our energy strategy.
