Annual Memorial Day Tribute to Local Veterans

The Newtown Historic Association held its annual Memorial Day tribute to honor local military veterans of World War II, Korea, and Viet Nam on Memorial Day, May 27th, 2024, at the Callahan Research Center. On display were over 100 pictures of local soldiers who fought in these wars. This collection was created by Mike Donovan, a past NHA member and history buff.

Also on display were letters written by soldiers containing their private thoughts and moments as they experienced war, and more than 300 World War II military shoulder patches from the U.S. Army, Army Air Force, Marines, Navy and Coast Guard—representing a variety of battles and war campaigns that took place across Europe and Asia with a special focus through the eyes of 12 Newtown natives and soldiers, not all of them coming home.

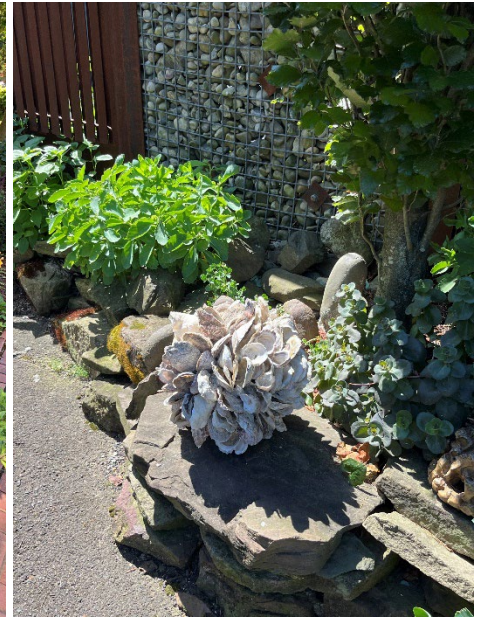
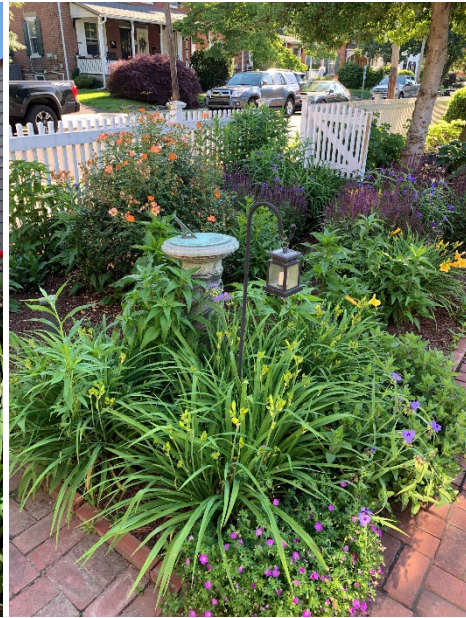

“The Doan Gang: Outlaws of the Revolution” Exhibit

The Mercer Museum in Doylestown, PA, is presenting a major new exhibition, [*The Doan Gang: Outlaws of the Revolution*](#), that explores the history and intrigue of a group of Revolutionary War-era Loyalists whose legend lives on today.

This exhibition investigates the extraordinary tales of the Doan Gang’s criminal exploits throughout the region and explores the conflicts that arose among neighbors, friends, and families in Bucks County who were forced to choose sides during a time of great political and social unrest.

The Newtown Historic Association played an active role in the research for the exhibition. Several historic photographs on display were provided by the NHA, and three NHA Board members—Dave Callahan, Jeff Marshall, and Rick Speranza—are publicly acknowledged for their efforts and contributions on the wall poster at the end of the exhibition.

The entire exhibition area is air conditioned, so keep it in mind for something to do on a hot summer day.

The exhibition runs until December 31, 2026, so there is plenty of time to experience it.



September General Meeting

The NHA is hosting local author and historian Scott Bomboy for our September general meeting, which will take place on **September 16th, 2024, at 7:30 p.m. at the Half-moon (Court) Inn**. The title of the presentation is "The Lost Covered Bridges of the Neshaminy Creek."

Bomboy will take a look back at the network of covered bridges that once spanned the lower Neshaminy Creek, featuring rare photos and local newspaper accounts.

At one time, six covered bridges spanned the creek from Bristol Township to Wrightstown: the Chain bridge, Worthington's Mill bridge, Schofield Ford bridge, Spring Garden Mill bridge, Oakford bridge, and Newportville bridge. Many bridges were associated with mills, which were critical to the local economy. Today, only one covered bridge remains on the creek, in Tyler State Park.

Each bridge has an interesting story to be told, as key players in the growth of lower Bucks County.

And each was lost in a different way. A question-and-answer session will follow the presentation.

This event is free for members. Non-members are also welcome to attend, and donations are always appreciated.

Tyler State Park Self-Guided Historical Walking Tour

The NHA will hold the next Tyler State Park self-guided historical walking tour on **Sunday, September 22nd, 2024, starting at 10:00 a.m. at the Tyler Park boathouse dam**. It will begin with an historical overview of the Tyler family, mansion, and park properties by Brian Rounsavill and a representative from the park.

This book provides you with the details on the self-paced and self-guided walking tour of the many historic Tyler State Park properties.

it will take you more than one day to visit all the sites.

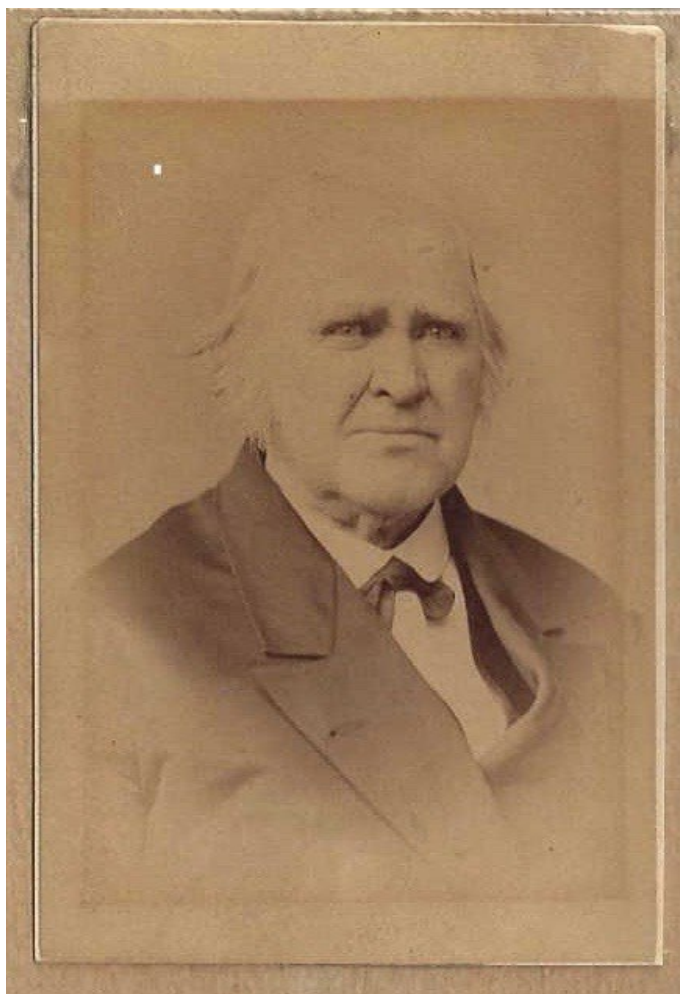

Moses Lancaster



Moses Lancaster, Notable Nimrod

I come across certain people in my research that stick with me for whatever reason. This man's reason is definitely his name, and the fact that Kenderdine called him a notable nimrod, though apparently it meant he was a skillful hunter and not a bumbling idiot. Here's some information on Moses' early life from a book review.

The following is from *Excerpt from a book review on Donna J. Rilling, Making Houses, Crafting Capitalism: Master Builders in Philadelphia, 1790-1850*. Review written by James B. McSwain, Department of History, Tuskegee University.

In contrast Moses Lancaster, a Bucks County Quaker, came to Philadelphia in 1802 and quickly advanced to master carpenter using personal contacts and financial resources from the Friends' community. Lancaster repeatedly mortgaged property to obtain cash for new projects or to pay for labor or materials advanced in anticipation of housing sales. He kept certain properties, relying on the income they produced to stay afloat during hard economic times. When possible, Lancaster hired apprentices to lower his wages costs and employed journeymen by the day, by the job, or for a specific task to make their labor efficient. Lancaster bought and sold real estate, sold titles to raise cash, and obtained ground rents to supplement his income. In 1823 he purchased a lumber yard and branched out into the materials side of building, enabling him to cut project costs, swap supplies for labor with other carpenters, and get out from under the constant need for cash to do business. Despite his skills and contacts Lancaster suffered reverses in 1828-30, and retired in 1841 to the countryside where he lived for many years on a modest income from rental properties. When he died in 1879 he was dependent upon the Carpenters' Company for daily needs. Lancaster's life in building makes clear the difficulties many men faced even when they achieved modest success as a master builder. His fortunes showed that many factors such as relationships, economic cycles, the scale of activities, the convergence of career stages and market developments, and diversity of interests, determined whether or not one could advance from apprentice to wealthy master builder in the construction business.

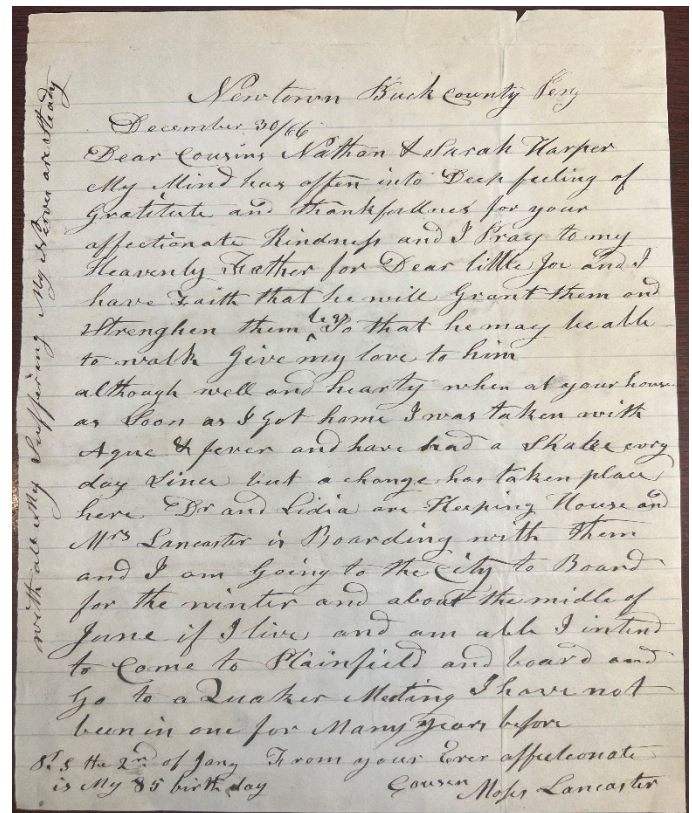
Moses and his wife Susanna had 12 children, the majority of whom lived to adulthood. Later in life, the couple boarded with their daughter Lydia and her husband, the head of the household Dr. Morris P Linton, at 35 S. State Street in Newtown. The residence was formerly part of the old jail when Newtown was the county seat. Linton owned the house from 1844 to his death in 1872, during which time the old Treasury Building still stood directly behind it.

By chance, I came across a letter written from Newtown by Moses Lancaster. He's writing to his cousins, Nathan and Sarah Harper, on December 30th, 1866. He was 3 days away from his 85th birthday, as noted in the postscript. In it, he says a little prayer and describes his declining health. He says that his wife is boarding with Dr. Linton and Lydia, and that he was going to Philadelphia to board for the winter with the intention of going to Plainfield in the summer "if I live." Despite the prayers, Moses notes he has not been to a quaker meeting in many years. In the margin, he pens "With all my suffering my nerves are steady."

Moses was remembered by historian Thaddeus S. Kenderdine in [his 1915 pamphlet, "When Newtown Was the County Seat."](#) The story is about some apprentice boys in the local lockup.

Dissatisfied with their accommodations, in the evening, and being small, 'prentice boy size, they climbed up the chimney, and, as crows, besmirched with soot, they cawed defiance to "Mosey" Lancaster, the chief Burgess, who lived in an adjoining house. As the defender of the honor of the borough, "Mosey" got out his gun, and ordered the boys to their quarters, but they shouted defiance from the chimney top till the small hours, when tired with their skylarking they went down to their donjon-keep. I well remember Moses Lancaster, who was a notable Nimrod, and who up to his ninety years roamed the woods for game.

When Moses Lancaster died, he was the oldest resident of Newtown at the age of 97.

Moses Lancaster Obituary

Moses Lancaster, the "oldest inhabitant" of Newtown, died at the residence of John Fenton, on the 15th inst. He was in the 97th year of his age. In the earlier part of his life he resided in Philadelphia, where he carried on the business of carpenter and builder. He became a member of the Carpenters' Company, a beneficial association, in 1811, and at the time of his death was the oldest surviving member. His remains were interred in Greenwood Cemetery on Tuesday. Mrs. Lydia Linton, widow of the late Dr. M. P. Linton, is a daughter of the deceased.

The NHA is hosting conservator and gold leaf specialist Paul Gratz for our November general meeting, which will take place on **November 18th, 2024, at 7:30 p.m. at the Half-moon (Court) Inn.** The title of the presentation is "Painting Conservation Techniques and Materials."

Paul Gratz in His Studio



Gratz's presentation on art conservation will explain how the combination of modern techniques with Old World craftsmanship offers the finest in treatment for oil paintings, murals, and gilt objects. Truly skilled art conservation preserves as much as possible of the original art itself, and therefore preserves its utmost value. Paul Gratz was a founding member of the Society of Gilders.
