Honor Ceremony for Sgt. Charles Duckworth Written by Baker-Fisher Camp 101

Baker-Fisher Camp 101 honored Sgt. Charles Duckworth in September at Newtown Cemetery. Sgt. Duckworth was the last Union veteran of Bucks County and the

Commonwealth of Pennsylvania.



Sgt. Duckworth served in the war as a private in the 18th Pennsylvania Calvary, Co. I and as a sergeant in the 3rd Provisional Cavalry, Co. F. He saw action in the 1864 Overland campaign and was able to see President Abraham Lincoln while riding through Washington.

After the war, Duckworth continued to live and work locally in Bucks County. He was heavily active in the G.A.R., serving as the last post commander of Capt. H. Clay Beatty Post #73, located in Bristol.

Sgt. Duckworth passed away at the age of 102 in 1949.

September General Meeting

The NHA hosted local author and historian Scott Bomboy for our September general meeting. The title of the presentation was "The Lost Covered Bridges of the Neshaminy Creek." Approximately 30 people were in attendance.

Bomboy took a look back at the network of covered bridges that once spanned the lower Neshaminy Creek, featuring rare photos and local newspaper accounts.

At one time, six covered bridges spanned the Neshaminy Creek from Bristol Township to Wrightstown. Today, only one

covered bridge remains on the creek, in Tyler State Park.



Each bridge had an interesting story to be told and were key players in the growth of lower Bucks County. Bomboy explained how each bridge was lost in a different way.



The presentation ended with a lively question-and-answer session, followed by snacks and cider.

November General Meeting

The NHA is hosting conservator and gold leaf specialist Paul Gratz for our November general meeting, which will take place on **November 18th**, **2024**, **at 7:30 p.m. at the Half-moon (Court) Inn**. The title of the presentation is "Painting Conservation Techniques and Materials."

Paul Gratz in His Studio



Gratz's presentation on art conservation will explain how the combination of modern techniques with Old World craftsmanship offers the finest in treatment for oil paintings, murals, and gilt objects. Truly skilled art conservation preserves as much as possible of the original art itself, and therefore preserves its utmost value. Conservation treatment restores original radiance, color, and detail to treasured oil paintings and art objects, adding years of life and maximum value to even the most damaged artwork.

Mr. Gratz is the owner of Gratz Gallery & Conservation Studio, Inc. Under his leadership, the gallery has represented American artists with numerous exhibitions and publications for over four decades. Most recently, Mr. Gratz started representation of an extensive collection of works by American Modernist, female painter, Peter Miller. The collection of over 220 works went through his careful art conservation and is

accompanied by a monograph on the artist published by Mr. Gratz in cooperation with art historian Francis M. Naumann.

Gratz Gallery has been a trusted representative for private collectors and museums in the expansion and upgrade of their fine American art collections. Over the years, Gratz Gallery has successfully sold to and represented a long list of renowned art organizations and private collectors, and assisted in exhibitions with fellow galleries and Fine Art Museums.

Mr. Gratz has been a private conservator for 40 years, working with Princeton University Art Museum for 30 years, providing conservation services for private collectors, prestigious national museums, and art organizations. The Conservation Studio specializes in the conservation and restoration of oil paintings and gilt frames.

Mr. Gratz's formal training began at the Pennsylvania Academy of the Fine Arts and was developed through various apprenticeships with some of the nation's most respected art conservators. While attending the Academy, Mr. Gratz studied with the esteemed Louis Sloane, the conservator and artist Joseph Amarotico, and the unparalleled instructor, Arthur DeCosta. Paul Gratz was a founding member of the Society of Gilders.





2024 Holiday Open House Tour

The cost of a tour ticket also includes entry into the Half-moon (Court) Inn, home to the Newtown Historic Association. Once inside this beautifully restored 18th century building, tour-goers will enjoy period musical entertainment, hearthside colonial cooking demonstrations, and more.
